## Honduras





#### HI Team and intervention areas

HI worked in Honduras between 1999 and 2010. In 2024, HI's programme for Latin America and the Caribbean has re-launched an intervention in Honduras. Since January 2023, HI in Honduras works through a technical assistance project focusing on Inclusive Humanitarian Action, in consortium with Action Against Hunger (ACF) and the Norwegian Refugee Council (NRC). Currently, this technical assistance is being finalized in the Northern Triangle of Central America (Honduras, Guatemala and El Salvador). Additionally, a new project to support people displaced by violence in Honduras is starting, in collaboration with a consortium led by NRC. Further projects are also being identified, building on these initial opportunities to ensure continued intervention in both Honduras and the broader Central American region. HI Honduras has currently a team of 4 staff members.

#### c) Geopolitical analysis

Honduras is in a complex humanitarian crisis, rooted in systemic poverty, deep socio-economic and gender inequality, in a context marked by widespread violence, forced displacement, gender-based violence, rights violations, as well as the impacts generated by mixed movements of refugees and migrants and the state's limited capacity to respond to the protection challenges faced by the population. Historically, Honduras has been a country of origin, entry, transit and, to a lesser extent, destination for refugees and migrants.

Criminal groups and organizations exercise control and people are denied access to health, education, work and the use of public areas as spaces for protection and participation. Children, adolescents, women and persons with disabilities are particularly vulnerable.

The diversity of shocks faced by the population have reduced the availability, quality and accessibility of basic systems and services. The reduction of commercial and productive activities due to the COVID-19 pandemic and storms has reduced tax revenues and public investments, disrupted social programs and weakened social safety nets, affecting long-term recovery. In 2022, heavy flooding in September and the effects of tropical storm Julia left many health care centers flooded and caused the loss of medical supplies and equipment, many in the same areas that were affected in 2020 by Eta and lota. According to the UN Humanitarian Response Plan 2023, during 2021, the humanitarian needs analysis revealed that 2.8 million people in Honduras were in need of humanitarian assistance. This analysis was updated in 2022 and indicated that these needs were exacerbated by a food security crisis, violence, human mobility, climate change and disasters, increasing the number of people with humanitarian needs to 3.2 million.



# Summary of HI presence in the country

**1999**: HI launches operations in Honduras in response to Hurricane Mitch.

**January 2003**: Creation of the Central America program with Nicaragua, El Salvador and Honduras.

**Up to 2010**: Implementation of a wide range of projects, including Community-Based Rehabilitation, inclusive education, early detection, and the inclusion of persons with disabilities in disaster preparedness.

2010-2011: Closing of the Central America program and systematization of experience.

**2020**: Decision to explore a possible new HI intervention in Central America (StratOp LATAM 2020-2024) in a context of growing humanitarian needs.

**2020**: Hurricanes Eta and lota: HI supports the humanitarian response by providing logistical expertise to meet humanitarian needs in Honduras.

2021-2022: desk review and exploratory missions by the LATAM regional team.

**January 2023:** Start of technical assistance on inclusion of people with disabilities as part of a consortium in Honduras, Guatemala and El Salvador.

**June 2023:** Start of a local consultancy to support the development of HI mission in Central America, based in Honduras

**July 2024**: Start of PROTAH+ project in consortium with NRC, MDM and Plan, funded by ECHO.

October 2024: Launch of HI in Honduras.
